WAGE SCHEDULE LEGEND

(1) **IUPAT PENSION**

\$1.23 of the IUPAT Pension contribution is allocated solely to deficit reduction; no benefits are accrued.
A 5% increase per classification for the IUPAT Pension starting 1/1/22 per the IUPAT Constitution.

(2) **BRACKETED DUES**

Administrative Dues Check-Off (actual 6%), IUPAT Administrative Dues Check-Off, Organizing Dues Check-Off, Unity Action Dues Check-Off and Vacation / Holiday are **deducted** from the hourly **Taxable Net Wage**.

All work performed in the state of California shall receive a premium of \$2.00 per hour. (Refer to Side Letter Agreement in current Master CBA)
